INDIVIDUAL REGISTRATION

Service Description:

- A valid email address and a unique identifier are required for each researcher.
- Multiple accounts for the same user are not permitted.

2. Identity Verification Policy

- Identity must be verified before account activation (via email or national systems).
- The Authority reserves the right to suspend or cancel accounts containing incorrect or misleading information.

3. Information Security Policy

- The platform complies with approved security standards to protect user data.
- Users are responsible for maintaining the confidentiality of their login credentials.

4. Personal Data Management Policy

- Users must regularly update their personal and professional information.
- Data is used strictly for service delivery in accordance with applicable privacy policies.

5. Experience and Research Areas Policy

- All information provided must be accurate, reliable, and free from any non-compliant content.

SIGP RESEARCH PROPOSAL (INITIAL STAGE)

Service Description:

This proposal represents the initial stage of expressing interest in participating in the program. It includes a brief overview of the project idea, its objectives, and its research field. The proposal is submitted through the program's e-portal and is used as a preliminary stage to screen applications and assess their alignment with program's objectives and stated challenges. This step helps ensure that only projects meeting the basic requirements proceed to the next stage of the evaluation process.

- Company Size: The number of employees must not exceed 250.
- Revenue Limit: The company's annual revenue must not exceed 200 million SAR.
- Headquarters: The company's headquarters must be located within Saudi Arabia.
- RDI Activities: At least 75% of the planned RDI activities must be conducted within Saudi Arabia, as outlined in the business plan.
- Nature of the Applying Entity: The applying entity must be a for-profit company.
- Academic Partnership: Applications must be submitted in partnership with an academic or research entity; this is mandatory requirement for the SETP track.

Service Description:

- The company must be established or in the process of establishment.
- The company must be in the research and development stage.
- The company must fall within one of the four national priority sectors.
- The parent company must be headquartered in Saudi Arabia.
- Completion of all required documents and licenses.

RESEARCH MATERIALS IMPORT PERMIT CERTIFICATE

Service Description:

This service enables research entities to obtain permits for importing chemical materials used in RDI, in accordance with Royal Decree No. (41772) dated 22/5/1447H, which assigns the Authority the responsibility of issuing permits for the import, export, re-export, and clearance of chemical materials required by research entities, in line with the Authority's regulatory mandates.

Requirements:

- The import must be strictly for research purposes (Research Use Only).
- The application form must be completed with accurate information about the materials to be imported.
- All required documents must be attached.
- The requested materials must not be classified as restricted under the Chemical Management System. If restricted materials are required, proof of compliance with the requirements of the High Commission for Industrial Security must be provided (available at: <https://sais.gov.sa/ar/services/chemical-resources-ar.html>).
- The importer bears full responsibility for any damages resulting from misuse of these materials or use for purposes other than those for which they were imported.

- The researcher is also required to submit their request through the Authority's electronic platform, maintain the confidentiality and privacy of the host entity's information, and comply with all approved internal policies and regulations, including any applicable regulatory requirements or service-related fees.
